## Something for our FWSA "hot dog" Skiers and Boarders

Beginning this November, the *Jeep King of the Mountain series* started a national grass roots program; the *Jeep Terrain Park Challenge* to benefit the Heuga Foundation for MS (multiple sclerosis). This series enables local winter resorts/organizers across the country to stage Jeep Terrain Park events in an effort to determine which ski and snowboard representatives from their resort/event will compete for a national crown.

Top finishers (male/female, skiers & boarders) qualify for the regional events, four of which are being held in our FWSA area. The top 4 in each category then qualify for an expense paid trip to the Terrain Park Challenge Finals held in conjunction with the Jeep King of the Mountain Finals in Squaw Valley. There is no entry fee to participate, but competitors are encouraged to make a \$5 or more voluntary donation to the Heuga Center. All participants will be entered in the final JTPC prize drawing which will take place at the Finals at Squaw Valley. There will also be a 4 minute TV segment about the Heuga Center as part of the televised Finals in Squaw Valley.

Grassroots will be comprised of local organizer or resort run events which commit as a qualifier (limited

to 10-12 per region) to the *Regional Jeep Terrain Park Challenge*. In exchange for their commitment to organize the qualifying competitions, the grassroots events will receive materials to enhance their event: Heuga Center information, JTPC banners, JTPC generic posters with space to provide their own event information, certificates to present to winners qualifying for the regionals, additional sponsor merchandise for drawings at their event, a JTPC gift for the first 50 to sign up for their event, and more.....

# Airlines Back Down on Ski Equipment Policies

Northwest Airlines backs down After Significant Opposition from Travel Industry & Ski Clubs

In the fall of 2005, Northwest Airlines tried to change its skiing/snowboarding equipment policy to count skis and boots as 2 separate pieces of luggage. After significant opposition in the form of emails and letters from the travel industry and ski clubs including FWSA, Northwest Airlines changed its policy back to its original policy which allowed skis and boots to count as one piece of luggage.

This one piece of luggage can not exceed Northwest's standard 50 pound weight limit or it will incur a \$25 overweight fee up to 70 pounds and a \$50 overweight fee for up to 100 pounds. Northwest accepts one item of skiing/snowboarding equipment in lieu of one piece of luggage included in the free luggage allowance. Skiing/snowboarding equipment is accepted as checked luggage only. An item of ski equipment is defined as one of the following: One (1) ski bag containing up to two (2) pairs of skis

and one (1) boot bag; One (1) snowboard; One (1) snowboard bag containing up to two (2) snowboards.

### Public Affairs Update Headlines Area Development

Arizona Snowbowl. Even though Arizona Snowbowl received approval in the final environmental impact statement for Alternative 2 improvement and snowmaking proposal with construction to start 7/1, Snowbowl agreed to postpone construction until the Federal District Court in Prescott, AZ renders a decision. A full trial which is expected to hinge on religious rights especially the Religious Freedom Restoration Act was concluded on 11/15 by Judge Paul Rosenblatt and a ruling is forthcoming.

Boreal Mountain Resort, CA is to become an all mountain terrain park, the first in northern California, for the upcoming 2005-2006 season.

Crystal Mountain, WA awarded a contract to Superior Tramway to build 100 passenger jigback tram over 2 years starting in spring 2007.

Hatcher Pass, AK regional ski resort proposed by JL Properties to Matanuska-Susitna Borough.

Mammoth Mountain, CA sale to Starwood Capital Group Global valued Mammoth at \$365 million and is expected to close in December 2005. This sale reduces Intrawest's stake to 15%. Starwood also formed joint venture with Intrawest real estate holdings to develop more than 1,000 residential and lodging units plus 30,000 square feet of commercial space in the Mammoth Lakes region. Mammoth is the 2<sup>nd</sup> most frequented U.S. ski resort with 1.5 million skier visits per year.

# Steamboat, FWSA 2007 Trip

Our 2006 ski week in Telluride is February 4 – 11, 2006. Our ten council trip leaders and ski week travel staff have been working hard to accommodate the participants from each council. Lodging is available in both the historic town of Telluride and in the Mountain Village. Everyone is looking forward to a week of skiing and partying with ski club members from all over the western United States.

Telluride has groomed trails, bowls, glades and chutes for all skiing ability levels. The mountain has 24% beginner terrain, 38% intermediate terrain and 38% expert terrain. Prospect Bowl links the two sides of the mountain with terrain for all ability levels.

By the time you read this article, it's probably too late to join us for Telluride but it's not too late to sign-

up for our 2007 ski week in Steamboat Springs, Colorado. The dates are January 27 – February 3, 2007.

Located in the Colorado Rockies, Steamboat is one of North America's largest ski mountains. With 143 trails, 3600 vertical feet, and nearly 3,600 skiable acres, Steamboat provides a variety of terrain for every level of skier. The trail classification is 13% beginner, 56% more difficult and 31% advanced/expert. There are definitely runs for every skier.

Steamboat is a complete mountain range with Mt. Werner, Sunshine Peak, Storm Peak, Thunderhead Peak, Christie Peak and Pioneer Ridge. Steamboat's six peaks are filled with groomed cruisers, bumps, steeps, open meadows, and legendary tree

skiing. The term “champagne powder snow” was coined in Steamboat.

During the 2004-05 season, Steamboat invested over a million dollars improving their chair lifts. Their uphill capacity is 32,158 skiers per hour with an eight passenger gondola, high speed quads, and a total of 20 lifts.

The last time the FWSA ski week was in Steamboat was 1997, when we had 640 participants. Sign-ups for this trip will begin in March, 2006. So, plan now! Save the dates January 27 – February 3, 2007 to attend our Far West Ski Week in Steamboat.

tions. A charitable donation will be made by FWSA in the name of the winning club/council and FWSA to the winner's designated local charity. The local charity must be a "Qualified charity" and provide proof to FWSA that they are a valid 501(c)(3) organization in order to receive funds. \$50 will be awarded to a qualified charity of choice for FIRST place in *each* class, for Wentworth Outstanding Publication and Outstanding Website. \$100 will be awarded to a qualified charity of choice for FIRST place winners in *each* class, for Tollakson Outstanding Club of the Year.

## Tollakson Outstanding Club of the Year Competition

ALL clubs in FWSA are eligible to enter the Tollakson Outstanding Club of the Year competition. A revered panel of judges will review all entries. Entries should consist of an essay describing how your club deserves to be named FWSA's Outstanding Club of the Year. Your essay should address what your club does for philanthropic efforts, the sport of skiing, and social events. Deadline for submittal is **May 1, 2006**. Essays should be no more than three pages. Send all entries to [vp.communications@cox.net](mailto:vp.communications@cox.net).

Rather than address club organization as in past years, the judges will focus on evaluating a club's activities for the year, as detailed in the essay. The categories or activities judged include the following, consistent with prior years' Tollakson Awards. Please structure your essay

in the order of categories noted below. Emphasis this year will be placed on areas of community outreach highlighted in bold:

- o **Non-Ski Activities** (30 points maximum)
  - Club & Member Community Activities and Services
  - Club Social Activities (Parties, athletic events, dinner dances, banquets, etc.)
- o **Sports Awareness / Promotion Activities** (20 points maximum)
  - Beginner/youth sports/ski programs
  - Handicapped/disabled skier programs
  - Ski area/community sports/ski programs
  - National Forest/Park guides, volunteers, etc.
- o **Sports Development Activities** (20 points maximum)
  - Sports/ski safety and instruction
  - Equipment update and information
  - Fitness, exercise, conditioning
- o **Sports Activities** (30 points maximum)
  - Ski (Alpine/Nordic) Competitive Events (Club, League, Council, FWRA, Other)
  - Non-Ski Competitive Events – tennis, volleyball, softball, skating, other Club, League, Council FWSA ski trips

Tollakson Outstanding Club recipients receive hard copy plaques. All judging is completed prior to the convention. Good luck to everyone, and may the best club be honored!

# FWSA AWARDS SCHOLARSHIPS

2005 was the second year where the Far West Ski Association has been able to award scholarships to deserving junior alpine racers. Applicants must reside in one of the six western states where FWSA has a presence or compete in a United States Ski Association (USSA) sanctioned program in one of these states.

Funding for our scholarships is provided by Big Mountain Resort, Grosse Mountain Lodge, and Schure Sports, Inc, makers of Karbon brand ski clothing. From donations by these fine enterprises, FWSA was able to accrue \$1,750. The Association added \$250 so that we were able to award a total of \$2,000 in scholarships.

Applicants were evaluated on: Financial Need – 30%; Academics – 25%; Prior Competitive Achievements – 20%; Community Activities – 15%; and their Goals and Desires – 10%.

This year the decision process was much more difficult than in the inaugural year of 2004 due to the volume of applications received by The Committee. A total of nine applications were received, from which The Committee awarded three scholarships.

## \$750 Scholarship

Anton Hiltz is a J2 racer who races with the Mt Batchelor Ski Education Foundation. He attends Summit High School in Bend, Oregon where he maintains a 3.8 GPA. In 2004 – As a J3 during the 2004 - 2005 season, Anton won two races at the national level: The Giant Slalom at the Lake Placid Race of Champions, and the Super G at the Junior Olympics at Snowbird, UT.



## \$750 Scholarship

Chris Hinkley is a J2 racer who competes for the Sugar Bowl Ski Team. He attends Sugar Bowl Academy in Norden, California, where he maintains 4.0 GPA. Chris, whose parents live in Juneau, AK, showed strong finishes in many races throughout the west in his first year of competition at the J2 level.

## Layering Strategy with Ski Clothes

The recommended way to dress for snowsports is by layering.

The *first layer* (next to your skin) should be a highly wickable, breathable base layer. **The moisture generated by your body sitting on your skin is largely responsible for making you cold.** There are many sophisticated fabrics on the market, which move the moisture away. Polyester seems to be the most popular, but you may also find long underwear, which is polypropylene, silk, or other fabrics. Most tops start at about \$15 and increase based on quality and features. I like the zippered ones because you can modulate your warmth level better.

The *Middle layer* should be also breathable and have some lofting ability. By that I mean trapping air to act as insulation. In nice warm ski weather you may skip this layer altogether. Fleece is one of the best materials to use. It is lightweight, does not restrict motion too much and feels great. Another great material is a relatively new breed of fabric like Gore-Tex Windstopper. This

## Sierra Council

It was about eight years ago when Doug Ball finally convinced me to come out for a Sierra League race. I've loved skiing for as long as I can remember and joined my first race team in 1971. Going through middle age, my enthusiasm was starting to get a little flat and my belly a little fat, so I thought if nothing else, trying to race again would get Doug off my back. Much to my amazement, my handicap times have improved each year, my enthusiasm for recreational skiing has skyrocketed, and racing has provided additional incentive to stay in shape year round.

I wanted to share some of the excuses I've heard from others about why they won't race, and I encourage you to build on these arguments to nag your friends about joining us.

1. "I'm afraid to get hurt." Running gates teaches you proper technique that carries over to skiing in every snow condition. What you learn about carving turns prevents injuries, because you develop good habits and proper form. Racing is about making good turns, not being reckless. It's OK to slow down and still maintain a stance suitable for racing. You never know when you'll ski through poor light and hit an icy section on the slope. Racing teaches you how to initiate a turn when you're sliding out.

2. "I don't want to wait around, when I could be skiing." If you spend \$100 for the annual race pass, Sierra League offers on-line registration, eliminating the need to register by 8:15 a.m. the day of each event. You just show up at the start, and after the first run, hurry back for your second run. Visiting with other racers

at the start is usually one of the high points of my day. When the event is over, racers group up and ski together. Some of the best skiing tips I've ever received came from fellow competitors after the race.

3. "I just want to ski for fun." I guarantee that it's more fun to ski when you know how to control them. Outsiders would expect that racers keep their speed secrets to themselves. In our league, just the opposite seems true. Our willingness to share tips about ski tuning or technique with each other is heart warming. Reno Ski & Rec member, Keisha Curtis, went from never skiing a day in her life three years ago to becoming the fastest woman in the eleven states of the Far West Division. She started racing about six weeks after her first day on skis, and this year won both the Slalom and GS races in the S-1 Open division at the West Coast Championships and the Nor Cals. Her incredible learning curve was largely due to fellow club members like Paul Laudenschlauger, Chris Buttenburg and Jim Sommers constantly giving her tips and encouragement while free skiing after the races.

I don't think there's a faster way to improve your skiing than racing. There ain't no style points for keeping your feet together, like in mogul competitions. The results in a race against the clock are totally objective, and I think that's why the exhilaration of a great run through a closed course is so satisfying. Thanks again Doug for keeping after me for so long to try racing.

material is breathable but resists air blowing through you by sandwiching a membrane in between the fabrics. A vest of this material will keep you cozy and keep your arms very mobile. You can zip it up to store your warms, or unzip for cooling. If you want to get really fancy, the Gore company is making products called Airvantage. This includes an inflatable bladder in a vest, which can be inflated or deflated to adjust your amount of insulation, what a concept!

The *outer layer* should be water and wind proof and ideally still have some breathe-ability. The windproofness reduces convective heat loss. By waterproof we really mean water-resistant. There is an inverse relationship between breathe-ability and

waterproofness. A rubber rain suit is very waterproof, but does not breathe. You will sweat inside and get wet and miserable. The best fabrics like Goretex XCR are light, breathable and relatively waterproof. Unfortunately, it is also expensive. A fabulous Mountain Hardware shell like this can cost you over \$400.00. Many companies have their own version of a breathable but waterproof fabric.

Invest in a good pair of *ski socks*. They use great wicking and insulating fabrics. Some use different panels to adjust for pressure and wear in your foot. Snowboard specific ones have a forward lean to them. Don't wear cotton or some crappy ones. If your feet are uncomfortable you won't have a good time. Make sure your boots fit properly and do not impair your circulation.
