Women's Ski Jumping Summer News: *Jessica Jerome* picked up her 11th National title at this summer's U.S. Ski Jumping Competition in Park City, Utah on August 2nd with a win in the large hill competition. *Nita Englund* and *Tara Geraghty-Moats* took 2nd and 3rd place, respectively. The 16th Annual Springer Tournee, held the same weekend, netted *Jessica* a first place on the 90-meter course, with teammates *Sarah Hendrickson* and *Nita Englund* placing 2nd and 3rd. The Fly Girls are off to a great start for the coming season. The normal hill Championships will be held in October, during the Flaming Leaves Tournament in Lake Placid, New York.

Bear Valley Mountain Resort Has Proposed New Owner: Skyline International Development Inc. signed an exclusive purchase agreement with the current *Bear Valley* ownership group. It hopes to partner with the Bear Valley Mountain Cooperative in future resort development. Skyline CEO Michael Sneyd sees a partnership between the co-op and Skyline as a key element in ensuring *Bear Valley's* future as a viable and productive resort operation. To make the operation profitable, they must continue to improve the brand in the Bay Area and bring back the ski-area visits that *Bear Valley* used to enjoy. Richard Lubin, Far West's Safety Chair, stated "If you've not ever been there, Bear Valley has an interesting attribute...the steepest part of the mountain (single and double black diamonds) is the bottom half, below the main lodge. It has the tendency to be regarded as a beginner and intermediate resort. There is some very steep and challenging terrain. One can drive there from the bay area without going over any summit, thus making it accessible even during storms. Hooray for Bear!"

Park City Mountain Resort: In the on-going eviction battle of *Park City Mountain Resort*, Talisker Corp., through their attorneys for the Canyons and Vail Resorts say that they will not dispute a halt of the eviction process if PCMR posts a bond that will cover the lease, interest and legal expenses for 2014-15. That exact amount remains in question. With *Park City's* ski trails leading right into the town, the City of Park City is on edge, not knowing the certainty of the resort's future. Fearing a dramatic decline in the local economy, business owners and public officials have urged a compromise after PCMR announced that if Talisker prevailed, it would deny access through the base area it owns and they would remove chairlifts from the leased land. Powdr Corp spokesperson, Krista Perry says "We hope that Vail and Talisker will work with us in proposing a reasonable bond to the Court so the 2014-15 season will proceed without interruption." The next court hearing is set for August 27th, 2014.

Far West Ski Foundation Plans for Giving: Everyone gives to their favorite cause or charity in some way or another each year. SNOW MISSING FROM NEW ZEALAND SLOPES

Ski operators throughout New Zealand are feeling the effects of the country's warmest start to the Southern Hemisphere winter since record-keeping began in 1909. Traditionally, a group of small ski areas that rely entirely on natural snow, many are facing steep financial losses this year. The areas are typically run as nonprofits. They are kept open not only by tourist dollars but also from the work of enthusiastic volunteers. The country's largest ski areas have managed to open only because they've invested in equipment to make their own snow, which they've been doing this year in unprecedented quantities. For now, at least, that's helped protect the nation's reputation as a winter play land, one that each year attracts more than 60,000 skiers and snowboarders from Australia alone from June to August when it is winter south of the equator. While one bad season doesn't prove a trend, it comes at a time when scientists say the country's snow pack and glaciers are melting at an alarming rate due to climate change. The *Craigieburn Valley Ski Area* is one of several areas that haven't opened for a single day this season, and some fear there may not be enough snow to open at all this year, something that hasn't been done in more than 30 years.
